### **MARCH 7 NHG MEETING**

Mistakes in Stone is a presentation focused upon the pioneering era in Western PA, north and west of the Allegheny River, south of Lake Erie and east of the border with Ohio. In that era, 1795 to 1840, illiteracy prevailed because of few educational opportunities and codification of the American version of English was slow to spread. Therefore, a cadre of engravers who were not literate produced tombstones for a clientele who were also largely illiterate. Many surnames are spelled incorrectly because of this fact of pioneer life. Of course many families altered surname spellings as well, most probably reflecting internal family dissension, and/or for reasons not known at present. Many surnames in the later 1800s were changed from eastern European spellings to create Americanized versions. In addition, grammatical errors abound in the realms of spelling, spacing, misuse of exclamatory and interrogatory marks and stones cut out of any regard for symmetry in the "sandstone" or pioneering era.

# The Crater at Petersburg Kevin Green

Following the Battle of the Crater on July 30, 1864, Lieutenant General Ulysses S. Grant said: "It was the saddest affair I have witnessed in the war." Pennsylvania miners were involved in the building of an underground tunnel between enemy forces. Was General Grant trying to keep some of his men "busy" or did he, actually, have a plan that he believed would work? What went wrong to what appeared to be a break in the Confederate lines for Union forces on July 30th?

Round Table member Kevin Green will look at some of the decisions that were made by the leaders on both sides and analyze how politics had an impact on this event. He will look at the military hearings and investigations that followed the battle and have an open discussion about the regiments and leaders involved.

### GETTYSBURG MONUMENTS VANDALIZED

Vandals hit Gettysburg National Military Park overnight Wednesday, damaging three Civil War monuments and stealing a 120-year-old sword.

Park spokeswoman Katie Lawhon said the intruders pulled the top stone and sculpture off the 11th Massachusetts Volunteer Infantry Monument. They also stole a sword from that monument.

In addition to the Massachusetts memorial, vandals pulled down the bronze sculpture of a Zouave infantryman from the pedestal of the 114th Pennsylvania Volunteer Infantry Monument. The third monument damaged was a bronze sculpture of an artillerman.

This is the third time in 18 months that vandals have damaged Gettysburg monuments.

If publishing about the Clark family, they would call it the "International Clark Family Yearbook."

These so-called books were not worth the paper they were printed on. ### ILLINOIS CIVIL WAR RECORDS ARE NOW ONLINE

The Illinois State Archives has expanded the information it now has online concerning Civil War veterans from Illinois at their Illinois Civil War Muster and Descriptive Rolls Database website.

It took historian Greg Koos just a few seconds to offer his review of a new state website.

"That's pretty neat." said the director of the McLean County Museum of History after a quick sampling of a new database that allows people to search the names and personal information of soldiers who fought in the Civil War.

"It makes it really convenient for people doing genealogical research," Koos said. "I can see how it would be useful."

The revamped research tool, available at www.ilsos.gov/genealogy, replaces large, bulky ledger books that could only be accessed at the state archives building in Springfield (IL).

### HERITAGE CREATIONS FILING FOR CHAPTER 7 BANKRUPTCY

Most of you know who Leland Meitzzler is. He has spoken at several NHG meetings and brought his 'store' of books, etc. for us to purchase. The following sad message from Leland recently appeared on his blog.

This is a blog I never expected to ever write, but circumstances have dictated that I do so today. Put in simple terms - I'm broke and am in the process of filing for Chapter 7 personal bankruptcy.

As most of you folks know, I bought back Heritage Quest Magazine, and much of the Heritage Quest retail operations from ProQuest three years ago. It was offered to me by ProQuest as a 'silver lining' to the fact that Patty and I were both being laid off, after 10 years with AGLL, Sierra and ProQuest. Although I knew that the operation was losing a lot of money, in my arrogance, I thought that I could turn it around and make it profitable. I had little money, but I had substantial credit available to me. I didn't want to see Heritage Quest Magazine go away. Having founded the magazine 17 years previously, my life was wrapped up in its publication. So I set off on the journey that ultimately cost us everything we owned. The operation lost money every month until we downsized in October. Since then, Patty and I have been working unbelievable hours in conditions that I'm sure no sane person would ever put up with. Doing this, I thought I'd found the key to making it profitable -- and I may have, only at that point the hole I'd dug was too deep to climb out of.

We sold our home in November, using the proceeds to finance that quarter's projects. We moved into a motorhome, parked in a local trailer park. In January we were looking at not only magazine publication expenses, but also a fair amount of taxes due. On the 31st, I was prepared to spend my last dime on magazine publishing expenses when it finally hit home that there was no way that I could make it through February. I was about a half million dollars in debt, with debt service alone eating up cash flow. That afternoon I met with my accountant as well as a bankruptcy attorney.

I've hurt a lot of people in attempting to operate this business as I have — and a large number of those folks have been personal friends — some for over 20 years. There are very few within the genealogical community that I don't owe in some way. I owe dozens of suppliers for product not paid for. I owe authors for articles written and not paid for. I owe subscribers for magazine subscriptions, both Heritage Quest, as well as Genealogy Bulletin. My friends have defended my integrity when times have been rough before. Now I'm letting everyone down, including those friends. I wish I could apologize to each of you personally, but that isn't humanly possible. At this point, all I can do is say that I'm sorry — and I know that isn't enough.

On a slightly brighter note, I'm quite sure that Heritage Quest Magazine and Genealogy Bulletin will find a new home, and the subscribers will get what they paid for. The subscriber-base of these two publications is substantial. This will have to be done with the blessing of the courts and ProQuest, who according to contract, gets all this back if I default. How long that may take I have no idea.

I will continue to blog, although my personal blogs may be a little thin for a few weeks. Joe will probably be doing a better job at that then I do anyway. I have a ton of paperwork to do, and that will continue to eat up all my time for a bit. My commercial websites will be coming down shortly. I have no idea what I'm going to do to earn a living. But maybe I'll go back to research -- which I love. I also plan to continue to operate a "Christmas Tour" to Salt Lake City -- as I have for over 20 years.

Please don't think too poorly of me, although I don't blame you if you do. I feel I gave it my best -- and that wasn't good enough.
